

Editorial Guidelines for Nordic Journal of Labour Law

Mission Statement

The NJLL is dedicated to advancing high-quality scholarly discourse on labour law issues particularly relevant to the Nordic countries. It aims to serve as an indispensable resource for academics, practitioners, and policymakers navigating the complexities of labour law.

Scope and Content

- **Focus Areas:** The journal welcomes contributions that provide in-depth analyses of Nordic labour laws, offer comparative insights, explore international implications, and examine EU/EEA-level regulations.
- **Types of Contributions:** Nordic Journal of Labour Law welcomes original scholarly articles, insightful book reviews, and critical commentaries on recent legal developments.

Editorial Process

- **Submission Review:** Initially, manuscripts undergo an editorial review to ensure alignment with the journal's scope and academic standards.
- **Peer Review:** Manuscripts meeting initial standards are forwarded for a rigorous double-blind peer review by distinguished referees.
- **Publication Frequency/:** The Nordic Journal of Labour Law follows a rolling online publication model, with an annual print compilation.

Author Guidelines for Nordic Journal of Labour Law

Preparation and Submission of Manuscripts

- **Document Format:** Manuscripts should be submitted as Microsoft Word documents, double-spaced, in 12-point Times New Roman font, with 2.5 cm margins on all sides.
- **Abstract and Keywords:** Each submission must include an abstract of no more than 250 words, succinctly summarizing the research and findings.
- **Length and Structure:** Full-length articles should not exceed 10,000 words, including footnotes. While this is a general guideline, submissions exceeding this limit will not be automatically rejected. Authors with substantial contributions are encouraged to contact the editorial team; the word limit serves as a guideline rather than a strict rule. Book reviews should be limited to 2,000 words. Each manuscript should be structured with clear, descriptive headings and subheadings to guide the reader through the argumentation and findings.
- **Submission Process:** Submissions should be sent electronically to the NJLL editorial office at nordicjournaloflabourlaw@outlook.com.

Style and Citation

- **Footnotes and References:** Footnotes and References: Footnotes should be used for supplementary comments and citations, formatted according to the Chicago Manual of Style.
- **Citations:** Direct quotations and paraphrased material must be properly cited within footnotes to acknowledge sources.
- **Acknowledgments:** Authors may include an acknowledgments section before the references to thank individuals or organizations who contributed to the research.

Editorial and Post-submission Procedures

- **Editorial Review:** The editorial team assesses submissions based on their contribution to the field, clarity of expression, and adherence to the journal's scholarly standards.
- **Proofreading:** Upon acceptance, authors are required to proofread typeset proofs to correct any typographical errors and ensure accuracy in the final published version.
- **Copyright and Licensing:** Authors retain copyright of their articles but grant NJJL an exclusive license to publish the work online and in print.
